

# GOVERNMENT RELATIONS

In an effort to keep members engaged around government relations matters, here are some recent legislative developments that influences Higher Education.



## THREE NEW INITIATIVES

The Department of Education (DOE), announced three initiatives this month, all of which have the potential to brighten the higher education landscape.

**Two of the programs** – [a more flexible Federal Work-Study](#) and [an expanded Second Chance Pell experiment](#) – take advantage of the Experimental Sites Initiative (ESI), a limited waiver that gives the Secretary the authority to waive certain federal regulations, thereby allowing colleges and universities opportunities to test new methods of administering financial aid. The third initiative – an enhancement of the [College Scorecard](#) – represents a broad set of improvement to that accountability portal introduced by President Obama. The data now includes 2,100 schools that award certificates but not degrees. Think barber and beauty schools and some schools that train health care workers. For the first time, prospective graduate students have access to reliable information about the debt levels of given programs.

## Election cycle debates - Free college and student-loan refinancing

In the first few months of the primary contest for the Democratic nomination, candidates have started to stake out their positions on whether to make college free in some form or provide some kind of relief for student-loan borrowers. In an effort to engage younger voters, candidates have released their [plans](#) well in advance of the 2020 election. Rest assured, Higher Education is going to be a hot button issue for the upcoming presidential race.

# AACRAO CONTENT COORDINATORS

In a response from AACRAO membership calling for the delivery of education and professional development content in other mediums while institutions experience shrinking travel and professional development budgets, AACRAO has recently announced the expansion of the Group Seven volunteer professional committee. This expanded group will encompass members who serve as content coordinators from the other six professional activity areas to provide content production and new or expanded methods of delivery.

Within this new structure for Group Seven, six members were announced as the workgroup after having been voted on by the committee chairs of Groups 1-6. Of the six members, two are OACRAO members!

**Roslyn Perry** from The Ohio State University will be the content coordinator for Group V – Access and Equity.

**Dan Wilson** from Muskingum University will be the content coordinator for Group VI – Information Technology.

# RESIDENCY WORKSHOP

On Tuesday, June 4, residency experts and novices alike gathered at the Student Academic Services Building on the campus of The Ohio State University for the 2019 OACRAO Residency Workshop.

The morning started with Panera pastries, coffee, and tea, along with an introduction to residency definitions and classifications presented by Tracy Sowards from Columbus State Community College. After a short break, the attendees had a question-and-answer session with a panel of residency experts, including Tracy Sowards; Michelle Chavanne, General Counsel from the Ohio Department of Higher Education; Lisa Delaney from The Ohio State University; and Dawn Evans and Ann Latham from the University of Cincinnati. Among the topics covered during the panel discussion were:

How to determine residency for students with pending asylum applications

Whether to automatically assume in-state residency for a student who graduated from an Ohio high school and has an Ohio address in your student information system (the answer is no!)

How to investigate students when hearing second-hand about a falsified answer to a residency question

Small group discussions continued throughout lunch, which Panera also provided. The panel session concluded after lunch with a discussion of the new C7 residency classification that covers students using federal veterans' educational assistance, along with talk about reciprocity agreements with adjoining states. The last session of the day began with Dawn Evans introducing a video produced by the University of Cincinnati that highlights students discussing Ohio residency requirements for tuition calculation (view the video at [https://youtu.be/Gk5KY3Z\\_33E](https://youtu.be/Gk5KY3Z_33E)) and ended with Ann Latham presenting UC's Early Residency Decision process, which is slated to go live in Fall 2020.

Our attendees learned a lot of useful information from their colleagues and our panel of experts. If you are interested in learning more about residency or sharing your experiences with others, be sure to join us at the Residency Workshop in 2020!




