## Veterans Affairs: Higher Education at Public IHL's and Compliance to Federal Law

As fall fades away and winter approaches, our thoughts turn to Veterans Day, Wednesday, November 11 and the armed forces members that have faithfully served our country. We thank you for your dedication to both our country and to all of us that enjoy the freedom you have protected.

A new law, The Veterans Access, Choice, and Accountability Act of 2014 was written primarily to address veteran health care concerns, but section 702 of the law addresses the veteran being charged in-state residency rates at all public institutions of higher learning. This legislation was to take effect on July 1, 2015, however, due to compliance legislation not being passed in all 50 states, the requirement was delayed to take effect for coursework taken after January 1, 2016. With the passing of Ohio HB 64 of the 113<sup>th</sup> General Assembly, Ohio is now compliant, along with 48 other states, Guam, the Virgin Islands, and Puerto Rico.

Section 702 of the Veterans Access, Choice and Accountability Act of 2014 ("Choice Act") requires the VA to disapprove programs of education for payment of benefits under the Post-9/11 GI Bill and Montgomery GI Bill-Active Duty at public Institutions of Higher Learning (IHLs) if the school charges qualifying veterans and dependents tuition and fees in excess of the rate for resident students.

To remain approved for the VA's GI Bill programs, schools must charge in-state tuition and fee amounts to "covered individuals." A *covered individual* is defined in the Choice Act as:

- A veteran who lives in the state where the IHL is located (regardless of his/her formal state of residence) and enrolls in the school within three years of discharge from a period of active duty service of 90 days or more.
- An individual using transferred benefits who lives in the state where the IHL is located (regardless of his/her formal state of residence) and enrolls in the school within three years of the transferor's discharge from a period of active duty service of 90 days or more.

## “Exit Wounds” by Jim Lommasson

Ohio University had the privilege of hosting Jim Lommasson on campus November 9-10, 2015. Mr. Lommasson's book, *Exit Wounds*, tells the stories of American veterans of the Iraq and Afghanistan wars. The stories are told via photographs and interviews by the author with the soldiers.

Mr. Lommasson interviewed fifty soldiers for his book, *Exit Wounds*. His exhibit and the book provide insight into the soldiers' lives by sharing their personal photographs, their stories, and highlighting some deep thoughts from the men and women who fought in the Iraq and Afghanistan wars. Every soldier has a story, some will share and some will not. If a soldier decides to share their story with you be sure to “listen with your heart.”

Here are a couple of quotes that stuck with me,

“We don't want handouts or special treatment. All we want is for people to understand us, to give us the respect we deserve. It was really hard for me to write this, to remember all this stuff. Thank you to all who I served with. There will be none that can take your place. You are friends and brothers that I will love for eternity.”

“Before we as a people send our youth into war, we have a responsibility and an obligation to fully understand the enormity of what it is we ask them to do.”

*Exit Wounds* is not an easy book to read, but it is an important book for us to read in order for us to begin to understand what it is that our men and women of war are dealing with. “To truly honor the warrior every patriotic American must bear witness to their stories and their pain.” Thank you, Mr. Lommasson, for sharing our American veterans' stories.





- An individual using benefits under the Marine Gunnery Sergeant John David Fry Scholarship who lives in the state where the IHL is located (regardless of his/her formal state of residence) and enrolls in the school within three years of the service member's death in the line of duty following a period of active duty service of 90 days or more.

A person described above will retain *covered individual* status as long as he/she remains continuously enrolled (other than during regularly scheduled breaks between terms) at the public IHL.

Ohio HB 64 does not require a veteran, their spouse, or dependent using transferred benefits to enroll within the three year time period following their honorable discharge. Other than that, Ohio compliance supports the federal requirement.

The challenge for us is to identify those students that qualify under this law and change their residency status accordingly so that as a public IHL we will remain in compliance. We are seeing an increased number of veterans and their spouses or dependents enrolling in higher education and acclimating back into the workforce, and it is our job to serve them now just as they have served us in the past.
