#### VETERANS AND HIGHER EDUCATION

Recently the State and Federal Governments passed some significant legislation concerning Veterans and Higher Education. Two of these have major applicability to us here in Ohio:

The Ohio Legislature passed House Bill 488 that the Governor signed into law this Summer. The law concerns efforts that we all must take to better serve Veterans on our campuses. Specifically, it requires the following by Dec 31, 2014:

- (A) Designate at least one person employed by the institution to serve as the contact person for veterans and service member affairs. Such a person shall assist and advise veterans and service members on issues related to them, and this person cannot be the primary VA certifying official.
- (B) Adopt a policy, signed by the Board of Trustees, regarding the support and assistance the institution will provide to veterans and service members.
- (C) Allow for the establishment of a student-led group on campus for student service members and veterans and encourage other service member- and veteran-friendly organizations.
- (D) Integrate existing career services to create and encourage meaningful collaborative relationships between student service members and veterans and alumni of the institution, that links student service members and veterans with prospective employers, and that provides student service members and veterans with social opportunities; and, if the institution has career services programs, encourage the responsible office to seek and promote partnership opportunities for internships and employment of student service members and veterans with state, local, national, and international employers.
- (E) Survey student service members and veterans to identify their needs and challenges and make the survey available to faculty and staff at the state institution of higher education. Periodically conduct follow-up surveys, at a frequency determined by the board, to gauge the institution's progress toward meeting identified needs and challenges.
- (F) Establish an appeals procedure for students who are veterans or service members for resolving disputes regarding the awarding of college credit for military experience.
- (G) Each state institution of higher education shall provide a student who is either a veteran or a service member with priority for course registration.
- (H) No state institution of higher education shall charge a student who is a veteran or a service member any fee for the evaluation of, transcription of, or application for college credit for military experience.

Some reference notes for OACRAO members:

- (A) The goal is to ensure that there are both administrative and advising support for our veteran and service member students by requiring that more than one person be engaged. So, if the certification requirement is handled by your office, you'll want to make sure there is other support for the students as

- (F) Since all of the USO institutions are already required to have an appeals process in place regarding the evaluation of transfer credit, this expectation is building on that process. So, at your institution, what training and other updates might need to happen in order to be confident that your current appeals process can also accommodate military experience credit?
- (G) While each of the USO institutions must provide priority registration for veteran and service member students, there are some important specifics to consider:

Do you have a good structure in place to identify your veteran and military service students so that you can provide the registration priority? The toolkit (referenced in the next paragraph) provides a sample template for identifying the students, and additional information about tracking and managing information about the students. If you have some priority structure in place for students, you need to determine "where" within that structure your institution wants to place veteran and military students. The legislation doesn't go into that level of detail. Some examples are included in the toolkit. If you don't have any priority registration at your institution, it would be a good idea for you to tap into some of the resources available from the toolkit.

The OBOR held a one-day conference on Oct 21<sup>st</sup> to begin this process and has also created a helpful "Valuing Ohio Veterans" online toolkit with reference information, samples, and POCs to assist: <a href="https://www.ohiohighered.org/valuing">https://www.ohiohighered.org/valuing</a> ohio veterans/toolkit

It also requires the following by July 1, 2015:

• Ensure that appropriate equivalent credit is awarded for military training, experience, and coursework that meet the standards developed by the chancellor pursuant to this section.

**NOTE** – The law also requires that The Chancellor of the Ohio Board of Regents (OBOR) shall provide guidance to state institutions of higher education in their compliance with this section, including the recommendation of standardized policies on support and assistance to veterans and service members.

\*\* To assist this process further, in the Spring of 2015 the OBOR, in conjunction with OACRAO, will host 5 regional training sessions across the state concerning the awarding credit for military training, education, and experience.\*\*

On the Federal side, Congress passed the *Veterans Access, Choice and Accountability Act of 2014,* which was signed into law in August to help with the VA healthcare issues. Part of this law, however, requires that starting July 1, 2015, all public universities and colleges in the U.S. offer in-state tuition to anyone using the Post-9/11 GI Bill benefits within 3 years of the military member's separation. Ohio, through the "GI Promise" legislation, offers a similar provision for Veterans, and their family members, attending Ohio Public colleges and universities. We've asked the OBOR to look at our state's requirements and see if they need any adjustment based on this new federal law. Regardless, you should be working with your Veterans/Military office and VA certifier to work out the details and impact of this new law for your campus.
